**TERMS OF REFERENCE**

- I. **PROJECT TITLE:** Procurement of Radio Broadcasting Services for the Airing of the "**CAIGANDang Cagayan**" Program
- II. **APPROVED BUDGET FOR THE CONTRACT: PHP 6,066,960.00**
- III. **PROJECT DURATION:** Five (5) months

IV. **RATIONALE:**

One of the mandates of the Provincial Government of Cagayan (PGC) is to provide the general public, especially its constituents, information that would let them be aware and give them better insights of all its programs, plans and projects of the province. Utilizing the Radio and Television Broadcasting Services are one of the most effective means to disseminate information along with the introduction of the different programs at its widest specific target audience.

V. **OBJECTIVE:**

To be able to air (Blocktime) the "**CAIGANDang Cagayan**" Program of the Provincial Government of Cagayan in thirty (30) minutes that would cater/cover the city/municipalities of Cagayan, and possibly be some areas of Kalinga and Apayao provinces, and Northern Isabela in an AM Band Radio Broadcasting Company.

VI. **PROJECT COMPONENTS:**

**A. Scope of Work**

Radio Program Airtime (Blocktime) for "**Caygandang Cagayan**" Program at Thirty (30) minutes airtime, 5:30AM – 6:00 AM, Mondays to Saturdays.

The airing shall be anchored by personnel allowed only by the Cagayan Provincial Information Office (CPIO).

**B. Technical and Manpower Requirement**

Technical Personnel organic with the radio station must be present during airtime to facilitate mirror broadcast from any CPIO Capitol Broadcast Studio or any location. Also, they will assist in any technical needs pertaining to the radio program such as phone patching and/or graphic overlay research.

**C. Other Specifications**

In any case that the radio company, due to public emergency or necessity, legal restrictions, act of God, strikes, lockouts, nor at the discretion of the national or local authorities, or for any reason beyond its control, is unable to broadcast the program at the time specified, a satisfactory substitute time for the broadcast of the program shall be implemented, the radio company, however, shall advise the block timer of its inability as early as much as possible.

The Provincial Government of Cagayan shall be the approving authority for all operations-related activities.

**VII. PAYMENT TERMS:**

The Approved Budget for the Contract is inclusive of all applicable government taxes and charges, professional fees, and other incidental and administrative costs. The contract price shall be a fixed price contract which shall be paid on a monthly basis (*after monthly airtime service*). Any extension of contract time shall not involve any additional cost to the Provincial Government of Cagayan. No advance payment shall be made as provided in pertinent provisions of PD 1445 (The Government Accounting Rules of the Philippines) and Section 338 of RA 7160 (The Local Government Code of 1991).

**VIII. LIQUIDATED DAMAGES:**

If the Supplier fails to satisfactorily deliver/perform the services within the period specified in the Contract inclusive of duly granted time extensions if any, the Provincial Government of Cagayan, shall, without prejudice to other courses of action and remedies available under the circumstances and applicable laws, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay as provided by the Government Accounting and Auditing Manual.
